Camp confirmation:

A confirmation email will be sent to the applicant after receiving the application form and payment slip.

Payment:

A receipt will be sent to the applicant once payment is received. Applicants must settle full camp fee before the camp. OSC reserves the right to withdraw or preclude the student from joining the camp if student has not settled the full camp fee.

All payments are non-refundable once the student's placement has been confirmed.

Refund Policy:

There is no refund if a place is confirmed by OSC. However, in the event that the camp needs to be cancelled by OSC, we will do a refund.

Refund Procedures:

- We will inform the parent/student of refund arrangements either by phone or in writing (e-mail, fax or letter).
- We will refund camp fee payments to the student in accordance to the above policies.
- We will issue a refund receipt to the parent/student and parent/student are required to sign to acknowledge receipt of the refunded payment.
- Refunds will be paid in the form of cash or cheque payments.

Others:

- Parents/students agree not to reproduce, distribute or show to any other person, in whole or in part, any of the class materials, lesson notes, assessments and tests distributed by OSC without the prior written consent of OSC.
- Parents/students are not permitted to solicit or make private arrangements for tuition with instructors/tutors employed by OSC.
